The registration fee is due at the time of registration and is non-refundable. This fee is \$150 per chi \$200 per family. This fee is an annual fee and must be paid on the anniversary date of your enrollment.	ld or

If space is not available at the time of registration, your child will be placed on our waiting lis will contact you when space becomes available. Registration fee plus one week's tuition is require be placed on this list.	
Tuition and Other Fees	
Tuition is paid weekly or monthly in advance with no deductions for absence, holidays, teach workdays and days the school is closed for inclement weather. Tuition is due Friday for the upcomin week. If the tuition and fees are not paid in full by close of business the following Monday, a late fee will be assessed, and the child will be subject to dismissal.
